For Small Businesses facing financial issues

Grants of up to \$10,000 are available to small businesses experiencing economic distress and sudden loss of revenue due to COVID-19. Grants are administered by the [Arizona Community Foundation](#), with preference given to businesses owned by veterans and underrepresented groups located in economically distressed areas of Phoenix. SBA Disaster Assistance Loan Application: The **U.S. Small Business Administration (SBA)** has streamlined its **Disaster Assistance Loan Application**. Companies can apply for emergency loans and small business assistance at the **SBA Disaster Assistance Loans Portal:** <https://covid19relief.sba.gov/#/>.
